# 2. Hazard Identification

**EMERGENCY OVERVIEW:** May cause eye, skin, or respiratory tract irritation. KEEP OUT OF REACH OF CHILDREN. Harmful if inhaled. Harmful if swallowed. Causes eye irritation. # 4. First-aid Measures
