#### 4. First aid measures.

## 5. Fire-fighting measures.

#### GENERAL INFORMATION

Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health. #### 8. Exposure control / personal protection.

#### 8.1 Exposure limit values.

### 8.2 Exposure controls.

As the use of adequate technical equipment must always take priority over personal protection equipment, make sure that the workplace is well aired through effective local aspiration or bad air vent. 
