4. First aid measures.				
<p>EYES: Irrigate copiously with clean, fresh water for at least 15 minutes. Seek medical advice.</p> <p>SKIN: Wash immediately with plenty of water. Remove contaminated clothing. If irritation persists, seek medical attention. Wash contaminated clothing before using them again.</p> <p>INHALATION: Remove to open air. 5. Fire-fighting measures.				
<p>GENERAL INFORMATION Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health. 7. Handling and storage.		
<p>Avoid the accumulation of electrostatic charges. Store the containers sealed and in a well ventilated place. Vapours may ignite with explosion, it is therefore necessary to avoid accumulation keeping the windows and doors open, ensuring crossventilation. Without adequate ventilation, the vapours may accumulate at the bottom and ignite at a distance, if triggered off, with the risk of flashback. Keep far away from sources of heat, sparks and bright flames. Do not smoke, use matches or lighters. Keep the containers earthed while decanting and wear antistatic boots.</p> <p>Vigorous stirring and flow through the pipings and equipment may cause the formation and accumulation of electrostatic charges due to the low conductivity of the product. In order to avoid the risk of fire outbreak and explosion never use compressed air during movement.</p>

<p>As the use of adequate technical equipment must always take priority over personal protection equipment, make sure that the workplace is well aired through effective local aspiration or bad air vent. 10. Stability and reactivity.			
The product is stable in normal conditions of use and storage. In the event of thermal decomposition or fire, vapours potentially dangerous to health may be released.			
11. Toxicological information.			
Acute effects: contact with skin may cause: irritation, erythema, edema, dryness and chapped skin. Vapour inhalation may slightly irritate the upper respiratory tract. Ingestion may cause health disorders, including stomach pain and sting, nausea and sickness.
