4. First aid measures.

EYES: Irrigate copiously with clean, fresh water for at least 15 minutes. Seek medical advice.

7. Handling and storage.

Store in a well ventilated place, keeping the containers closed when not used. Do not smoke while handling. Keep far away from sources of heat, bright flames and sparks and other sources of ignition.

8. Exposure control / personal protection.

8.1 Exposure limit values.

8.2 Exposure controls.

As the use of adequate technical equipment must always take priority over personal protection equipment, make sure that the workplace is well aired through effective local aspiration or bad air vent. 10. Stability and reactivity.

The product is stable in normal conditions of use and storage. When heated or in the event of a fire, carbon oxides may be released and vapours which are dangerous to health. The vapours may also form explosive mixtures with the air.

Mineral white spirits (oil of turpentine) reacts violently with strong oxidizing agents and chlorine. May ignite on contact with stannic chloride: it dissolves rubber.

11. Toxicological information.

Acute effects: inhalation, cutaneous absorption and ingestion of this product are harmful. This product may imitate mucosas, the upper respiratory tract, and eyes. Exposure symptoms may include: stinging and irritated eyes, mouth, nose, throat; cough, respiratory disorders, dizziness, headache, nausea and sickness.

In the most serious cases, inhalation of this product may cause larynx and bronchial tube edema and irritation, chemical pneumonia and pulmonary edema. Upon contact with skin, this product may irritate it, causing an increase in skin temperature, swelling and itchiness. Ingestion of even small amounts of this product may cause serious health problems (stomach pain, nausea, sickness, diamhoea).

Upon contact with skin, this product causes sensitization (demailitis). Dermatitis derives from skin irritation on the areas which repeatedly come into contact with the sensitizing agent.
