#### **SECTION 4: First aid measures**

### 4.1. Description of first aid measures

Inhalation:

Seek fresh air. In case of respiratory stop, administer artificial respiration/oxygen (but not the

mouth-to-nose method)

Ingestion:

Not relevant, as the product is a gas.

Skin:

Seek medical advice immediately if symptoms indicate that the gas has been absorbed through

the skin. See below in case of frostbite.

On frostbite: rinse with plenty of lukewarm water (max 37 °C). Do not remove clothes until thawed. Seek medical advice.

Eves

Flush immediately with water (preferably using eye wash equipment) for at least 5 minutes. Open eye wide. Remove any contact lenses. Seek medical advice in case of frostbite.

### 4.2. Most important symptoms and effects, both acute and delayed

Splashes of gas in the eyes may cause frostbite. Direct contact may cause frostbite. The skin

becomes numb and white. Pains, reddening and wounds follow. The gas may displace

atmospheric air, thereby causing risk of suffocation.

4.3. Indication of any immediate medical attention and special treatment needed

In case of shortness of breath, give oxygen. Keep victim warm. Ensure that medical personnel are aware of the material involved, and take precautions to protect themselves.
