LABELING REVIEW

Final packaging of the Creativity Street activity kit was reviewed. Product complies with all required statements and warnings, as follows:

- Age grading was present and appropriate. Product is age graded for "Ages 5 to Adult"
- Small parts warning statement per 16 CFR 1500.19 is required and present. The signal word "Warning" should appear on the same line as the triangle, per 16 CFR 1500.19. Type size and placement of warning per 16 CFR 1500.19 and 1500.121 is acceptable.
- Cautionary statement regarding functional sharp points per ASTM F963-96a is required and present. Signal word "Caution" should appear on the same line as the triangle.
- Producer markings per ASTM F963-96a were present.
- Country of origin is present.
- LHAMA conformance statement, "conforms to ASTM D-4236" is included for Wax Works. This statement can also be included for Pom Poms and Chenille Stems. Tacky Glue includes LHAMA conformance statement on individual bottle.
