

General protective and hygienic measures:

The usual precautionary measures are to be adhered to when handling chemicals. Wash hands before breaks and at the end of work. Do not inhale gases / fumes / aerosols.

- Protection of hands:

The glove material has to be impermeable and resistant to the product/ the substance/ the preparation.
